Checklist

1. Passport enclosed?
2. Two quality **50mm x 50mm** passport photos enclosed?
3. Passport photos are really **50mm x 50mm**? The Embassy *will not accept your photos* if they are not **50mm x 50mm**.
4. Invitation letter from the company to visit (BUSINESS VISAS ONLY) and original (no copies accepted) letter from UK company? Note that your passport number must be listed on both the invitation letter and UK reference letter.
5. Completed application and order form?
6. Payment enclosed or are paying via credit card? Please provide an email address if paying by credit card.
7. **Non-UK nationals** who have been a resident of the UK for more than two years need to provide a copy of the following documents as proof of his or her stay in the UK for more than 2 years:
 - Stamp of Indefinite stay. OR
 - Utility bills pertaining to Current month, AND One for at least two years back (but not older than 30months).
 - Utility Bills include only Landline Telephone, Gas, Electricity, Water, Council Tax Bills and Tenancy Agreement. Bank statements/Credit card statements will not be considered as Proof of stay.
 - Mix and Match of the Utility bills are not acceptable.
 - In absence of 2 years residence proof in UK, case to be treated as Non UK National - this takes a minimum of 15 working days

For babies and young children under the age of 16 who need a visa, parents are requested to send in a copy of the child's birth certificate (scanned copy, faxed copies only) and a letter signed from both parents indicating permission for the child to travel. Parents are also requested to send a copy of their Passports by fax or email and to also send a copy of any India visas that have already been stamped on their Passports. Please **DO NOT SEND THE ORIGINALS**. Simply send a scanned or faxed copy of these documents.
